

Terms of Use and Private Policy

1. Introduction

These Terms will be applied fully and affect your use of this Website. By using this Website, you agree to accept all terms and conditions written in here. You must not use this Website if you disagree with any of these Website Standard Terms and Conditions. Syand Corporation provides services only to customers and clients in the United States of America at the current time. Functionality of certain website function and/or services may be limited outside of the United States of America.

2. Information Collection, Use, and Sharing

We, Syand Corporation (“We” or “Syand”) are the sole owners of the information collected on this site. We only have access to/collect personal identification information that you voluntarily give us via email, through this website or other direct contact from you. We will not sell or rent this information to anyone.

We will use your personal identification information to respond to you regarding the reason you contacted us and to perform services for you, if applicable. We will not share your information with any third party outside of our organization, other than as necessary to fulfill your request, e.g. to ship an order.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy. You can always refuse to supply personally identification information, except that it may prevent you from engaging in certain Site related activities.

3. Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following at any time by contacting us via the email address or phone number listed on our website:

- See what data we have about you, if any
- Change/correct any data we have about you
- Have us delete any data we have about you
- Express any concern you have about our use of your data

Syand complies with all federal, state, and local laws, including, where applicable the General Data Protection Regulation (GDPR) (EU) 2016/679

4. Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a lock icon in the address bar and looking for "https" at the beginning of the address of the Web page.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.

5. Google Analytics and Third-Party Tools

Syand uses tools such as “Google Analytics” or similar applications to collect non-personal identification information about use of this site. Google Analytics and similar tools collect information such as how often users visit this site, what pages they visit when they do so, and what other sites they used prior to coming to this site. Syand uses the information we get from Google Analytics and similar sources only to improve this site. Google Analytics and other similar programs collect only the IP address assigned to you on the date you visit this site, rather than your name or other identifying information. Syand does not combine the information collected through the use of Google Analytics or other similar programs with personally identifiable information. Information collected through these tools may include browser name, the type of computer system, internet service provider, and technical information about how a user connects to this website.

Our Site may use "cookies" to enhance the User experience. The User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. The User may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly. Syand uses various types of software to track clients, leads, and other information.

6. How We Use Collected Information

Syand may collect and use your personal identification information and non-personal identification information for the following purposes:

- *To run and operate our Site*
 - We may need your information to display content on the Site correctly.
- *To improve customer service*
 - Information you provide helps us respond to your customer service requests and support needs, more efficiently. We may also use the information to verify your account with us and maintain the safety and security of your account information and our products.
- *To personalize the user experience*
 - We may use non-personal identification information in the aggregate to understand how our site users as a group use the services and resources provided on our Site. We may also use aggregate non-personal identification information to measure the effectiveness and distribution of ads and services, and how people interact with our website, apps, and services.
- *To improve our Site*
 - We may use feedback you provide to improve our products and services.
- *To send periodic emails*

- We may use the email address to respond to their inquiries, questions, and/or other requests. If requested by you, we may also use your email address and/or contact information to send you electronic newsletters and information about products.

7. Electronic Newsletters

If you decide to opt-in to our mailing list, you will receive emails that may include company news, updates, related product or service information, etc. We may use third party service providers to help us operate our business and the Site or administer activities on our behalf, such as sending out newsletters or surveys. We may share your information with these third parties for those limited purposes, provided that you have given us your permission for such use of your information.

8. Restrictions

You are specifically restricted from all of the following, except as explicitly authorized otherwise in writing by Syand

- publishing any Website material in any other media;
- selling, sublicensing and/or otherwise commercializing any Website material;
- publicly performing and/or showing any Website material;
- using this Website in any way that is or may be damaging to this Website;
- using this Website in any way that impacts user access to this Website;
- using this Website contrary to applicable laws and regulations, or in any way may cause harm to the Website, or to any person or business entity;
- engaging in any data mining, data harvesting, data extracting or any other similar activity in relation to this Website;
- using this Website to engage in any advertising or marketing.

Certain areas of this Website are restricted from being accessed by you and Syand, and we may further restrict access by you to any areas of this Website, at any time, in our absolute discretion. Any user ID and password you may have for this Website are confidential and you are solely responsible for maintaining the confidentiality of such login credentials.

9. Your Content

In these Terms of Use and Private Policy, Your Content shall mean any audio, video text, images or other material you may choose to display on this Website. By displaying Your Content, you grant Syand a non-exclusive, worldwide irrevocable, sub licensable license to use, reproduce, adapt, publish, translate and distribute it in any and all media.

Your Content must be your own and must not be invading any third-party's rights. Syand reserves the right to remove any of Your Content from this Website at any time without notice. This privacy notice applies solely to information collected by this website. It will notify you of the following:

1. What personally identifiable information is collected from you through the website, how it is used and with whom it may be shared.

2. What choices are available to you regarding the use of your data.
3. The security procedures in place to protect the misuse of your information.
4. How you can correct any inaccuracies in the information.

10. No Warranties

This Website is provided as-is with all faults, and Syand expresses no representations or warranties, of any kind related to this Website or the materials contained on this Website.

11. Limitation of liability

In no event shall Syand, nor any of its officers, directors or employees, be held liable for anything arising out of, or in any way connected with your use of this Website whether such liability is under contract. Syand, including its officers, directors or employees, shall not be held liable for any indirect, consequential or special liability arising out of or in any way related to your use of this Website.

12. Indemnification

You hereby indemnify to the fullest extent Syand from and against any and/or all liabilities, costs, demands, causes of action, damages and expenses arising in any way related to your breach of any of the provisions of these Terms.

13. Severability

If any provision of these Terms is found to be invalid under any applicable law, such provisions shall be deleted without affecting the remaining provisions herein.

14. Variation of Terms

Syand is permitted to revise these Terms at any time as it sees fit, and by using this Website you are expected to review these Terms on a regular basis.

15. Assignment

Syand is allowed to assign, transfer, and subcontract its rights and/or obligations under these Terms without any notification. However, you are not allowed to assign, transfer, or subcontract any of your rights and/or obligations under these Terms.

16. Entire Agreement

These Terms constitute the entire agreement between Syand and you in relation to your use of this Website, and supersede all prior agreements and understandings.

17. Governing Law & Jurisdiction

These Terms will be governed by and interpreted in accordance with the laws of the State of Minnesota, and you submit to the non-exclusive jurisdiction of the state and federal courts located in Minnesota for the resolution of any disputes
